Per our discussion the following is a summary of the current status of the stormwater association that manages the stormwater system for these developments:

- The current Declarants are Allied Properties for Waterleigh and APVA for Currituck Reserve (now known as Wentworth).
- Justin Old is the Manager for both Allied Properties and APVA, and is therefore the member that currently represents both Declarants in the Moyock Stormwater Association, and as such is the point of contact for stormwater issues.
- The stormwater association has hired Chris Conner of Stormwater Pond Management to be the contracted management entity to look after these stormwater systems.
- Once these communities are sufficiently developed to be self-managing, or upon Turnover, each Declarant will be replaced by a representative of each community association who will then manage the Moyock Stormwater Association. The association may continue to use Stormwater Pond Management to operate the stormwater facilities, or may decide to use a different management entity.
